Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2020 to 2021 academic year.

Support for KS1 children with their early reading skills resulted in 100% of our Year 1 children meeting the expected standard in the Phonics Screening Test.

Families with financial difficulties during the pandemic were supported with access to virtual schoolwork by means of digital devices so that work on the Google Classroom platform could be successful for all children.
